# General Information

## ***Historical Sketch***

New Covenant Bible Institute of the Caribbean was born out of a need in the Church of God of Prophecy Jamaica to prepare and equip church leaders to deal with today's challenges.

The primary function is to provide a means of development of leadership within the church, through various initiatives.

The institution is concerned with:

- 1) Providing a programme of study that maintains a strong spiritual and devotional emphasis along with academics.
- 2) Facilitating the continuing development of biblical leadership that follows the Lord Jesus Christ's description of His own vision of leadership "I am among you that serves" (Luke 2:27) thus our motto was chosen.
- 3) Providing a curriculum that purposely designed to reflect the needs of our church.

New Covenant Bible Institute of the Caribbean from its inception is located at 41 Old Harbour Road, Spanish Town St. Catherine. The main school continues to be at this location with extension schools in Mandeville Manchester, Montego Bay St. James, and Ocho Rios St. Ann.

The programme of study caters also to other Christian leaders from other denominations.



## ***Statement of Purpose***

- To facilitate and provide leadership development and training on a continuous basis to the Church, thereby increasing the effectiveness of the local Churches.
- To work with the Church's leadership in enhancing proper relationships and maturity of members in the body.

## ***Statement of Faith***

1. We believe that Scriptures, both Old and New Testament are inspired word of God, without error in the original writings, the complete revelation of His will for the salvation of persons, and the divine and final authority for all Christian faith and practice.
2. We believe in one God, Creator of all things, infinitely perfect and eternally existing in three persons, Father, Son, and Holy Spirit.
3. We believe that Jesus is true God and true man, having been conceived of the Holy Spirit and born of the Virgin Mary; and that He arose bodily from the dead and ascended into heaven where he is now our high Priest and Advocate.
4. We believe that the ministry of the Holy Spirit is to glorify the Lord Jesus Christ, and to convict men of sin, regenerate the believing sinner, indwell, guide instruct and empower the believer for godly living and service.
5. We believe that man was created in the image of God but fell into sin and thereby incurred not only physical death, but also that spiritual death which is separation from God; and all human beings are sinful by nature and in need of redemption which can be accomplished alone by the grace and power of God.



6. We believe that the Lord Jesus Christ died for our sins, according to the Scriptures, as a repentance and substitutionary sacrifice; and that all who believe in Him are justified on the grounds of His sacrificial death and become heirs of eternal life.

7. We believe that the Christian life is a discipline, involving a personal response of faith and obedience to Jesus Christ and to the Word of God, leading to a life of holiness, witness, and service through the power of the Holy Spirit.

8.. We believe that the true Church is composed of all such persons who through saving faith in Jesus Christ have been regenerated by the Holy Spirit and united together in the body of Christ, which transcends and overcomes cultural, national, racial, and ethnic boundaries, and of which Christ is the head.

## ***Affiliation***

New Covenant Bible Institute of the Caribbean is sponsored by the Church of God of Prophecy and is governed by seven/nine-member board of Governors drawn from our laity, staff, student, and external academia. Each member serves for a period of two years and is replaced or re-elected at the end of the two - year tenure by the National Overseer; Church of God of Prophecy Jamaica.

# Academic Information

The New Covenant Bible Institute of the Caribbean Admission's Policy requires that High School graduates, or persons with the equivalent qualification are eligible for admission. However, persons with ministry experience can benefit from the programme.

Applicants, depending on their educational backgrounds or goals, are admitted at NCBIC in the following categories: diploma, certificate, audit.

## ***Admission Requirement***

1. Completed Secondary Education earning the minimum 5 subjects in CXC or CSEC (Caribbean Examination Council, Caribbean Secondary Education Certificate) including English Language or equivalent.
2. Proof of qualification
3. Verifiable ministry experience of a minimum of five years.
4. Reference letter from the applicant's Pastor/Minister
5. Completed application with photograph and prescribed fee.
6. Be a practicing Christian
7. Adhere to Code of Conduct found the student handbook

NCBIC does not discriminate in its admissions policy on the following bases: race, gender, colour, nationality, disabilities, or Christian denominational affiliations.

NCBIC accepts all candidates who apply for training in Christian Leadership:

1. Candidates with 5 CXC or its equivalent will be accepted for the Diploma Program.
2. Candidates without the CXC requirement will be accepted for the Certificate Program, however, students can be transferred from the Certificate Program to the Diploma program if they meet the prescribed grade point average (2.7) set by the school.



Certificate students will do only the following subjects:

1. Introduction to Bible
2. Christian History
3. Introduction to Theology
4. Church Administration
5. Church of God of Prophecy History & Polity
6. Communication
7. Spiritual Formation

Diploma students will do all the courses (see list of courses in the Prospectus)

## **Registration**

All students are required to pay a registration fee; this fee is non-refundable. NCBIC accepts all candidates that apply for training in Christian Leadership with the necessary requirement.

## **Orientation**

All students are required to participate in the orientation sessions at the beginning of the school year. Orientation is an activity that serves to assist students in familiarizing themselves with what goes on at NCBIC. This includes a general overview of policies and procedures and services of the Bible School. Each student is provided with an orientation document.

## **Exemptions**

Students coming from other bible school may be eligible for exemptions from certain courses. Exemptions are granted by the Administrator/President of NCBIC on a case-by-case basis upon written request of student.

## **Online study**

Courses are also offered online on an individual basis. It is designed to meet the demands of a student who would be otherwise unable to attend classes. To be eligible for participation, a student must have tertiary level certification. Written permission to enroll must be secured from the President, Online Coordinator or his/her designate of NCBIC.

## **Internship**

All lay ministers who are eligible for graduation must complete the internship programme before certification. This programme will be supervised by the lecturer/pastor.

## **Certification**

Diplomas are granted to students with the prescribed prerequisite of 5 CXC or CSEC subjects.

The foundation Certificates are offered to all other students.

## **Other Grading Notations**

### **Audit**

Students registered for the class on an audit basis: students attend regular classes participate and is not obligated to write papers and do examination. No grade will be assigned to students. Student will be given certificate of participation. Student will pay 20% of tuition fee plus registration fee.



## ***Transcript***

Every student receives a report of his grade upon request.

Transcript forms are available at the office. Payment must accompany request for transcript.

## ***Plagiarism***

As a student of NCBIC, all papers that you submit should be your original work with appropriate referencing and citations using the Kate Turabian format ([www.eturabian.com](http://www.eturabian.com)). Please ensure that you access the latest edition referencing manual so that your references and citations are appropriate and accurate. If plagiarism, unauthorized assistance, copyright infringement, misrepresentation or collusion is detected; disciplinary actions will be taken such as failure of the course, suspension, or expulsion from our school.

## ***Written Coursework Assignments***

All assignments should be typed using the font Times New Roman and a font size of 12. Assignments should be submitted by the deadline given unless special permission has been granted by the lecturer for an extension. Late submissions may result in a deduction in the written coursework grade. As a student of NCBIC, you are expected to ensure that you have carefully reviewed your assignments prior to submission, to ensure it is free of grammatical errors, run-on sentences, and poorly constructed sentences. Information presented should be clear, concise, and relevant to the assignment.

## ***Course Preparation***

When preparing for your course, read widely on the subject area to become familiar with the content. Reading sources are indicated on the course outline but, other relevant material should also be read. The library can assist you in locating the appropriate reading material either directly in the library or through online databases. Each facilitator is expected to prepare lecture notes or slides to be distributed to the students at the end of the course or on a weekly basis. The Course head will provide material that may be deemed useful for the course as a guide in covering what is outlined on the syllabus. The course is set to last for ten/thirteen weeks, and it is required as a matter of policy that exam

questions be submitted by the fifth week of the course to the course head so that by the seventh week the final exams will be ready and seen by all facilitators of the course.

## ***Class Attendance***

Each student is expected to attend all the classes allocated for the course. However, students are required to attend a minimum of 93% of their classes, that is, 9/12 classes. Failure to meet this requirement will result in student being barred from sitting their final examination. If students are experiencing difficulties that could affect their attendance, it is the prerogative of the student to inform the lecturer and faculty as soon as possible. A registered student should ensure that he or she signs the register for his or her class each session in attendance.

## ***Class Register/ Grades***

Within every organization there is a system of accountability and record keeping. The use of a class register is the only means of accurate accountability of our students and their attendance. Once the new term has begun the campus secretary/coordinator should provide the lecturer with preliminary list of students registered for the course.

At the end of each semester lecturers should submit their grades no later than two weeks after the exam has been administered. The administration of the school will take another two weeks to scrutinize the grades and then disburse stipend to individual bank accounts or individual lecturers.

## ***Course Offerings and Enrolment***

The course is developed as a part-time programme. Certain courses are offered in the first year and second year. NCBIC reserves the right to regulate the number of students in a class and to cancel any class with insufficient enrolment, usually less than 10.

## ***Graduation Requirements***

Graduating students are required to have completed all subjects. The graduation runs concurrently with the COGOP Jamaica Convention Year which is biennially. Final grades for all students eligible for graduation must be properly submitted to the administrative secretary on a timely basis for submission to the national office



in any event a graduate should be called in for ministerial interview. Students upon completing the required courses and was set forth by their local church as a lay minister must immediately proceed to apply for internship. All students are responsible for fulfilling all requirements for graduation. All graduating students are required to pay a graduation fee. Graduation schedule is set forth in students orientation document.

### **Lecture Seminar**

From time to time the Christian Education Development Unit (CEDU) and its members will embark on guest lectures or various forms of seminars. It is expected that students will participate to better develop themselves theologically. An attendance to any of these seminars will result in a student being awarded 5% to assist with maximizing their chance in passing the course.



# Financial Information

## ***Student Expenses***

The costs for the current academic year are available from our office at 41 Old Harbour Road, Spanish Town St. Catherine, or our National Office at 6 Phoenix Ave. Kingston 10.

## ***Payments***

Students' accounts are due and payable at the time of registration. A deferred payment plan is available. Under this plan the student pays at least half the bill on registration. He then receives a bill to be paid in full at the end of the fifth week of the semester. Failure to pay the student will be asked to terminate the course.

# Academic Objectives

## ***Spiritual Formation***

Students will demonstrate an understanding of the process of Spiritual Formation through the influences and disciplines.

## ***Introduction to Bible***

1. To introduce the student to the external and historical origin of the Holy Scriptures.
2. To trace the "translational" process of the canonical writings
3. To help the student appreciate the Bible as literate and divinely authoritative book.

## ***Christian History***

The course is designed to introduce the students to basic history of the Christian Church, by conducting a historical survey of major events in Christianity, the key personalities, and the major movements.

## ***Introduction to Theology***

The individual will demonstrate an understanding of the nature, source, and scope of theological study by defining theology, and explaining its relevance to the church.

Paul prayed in Ephesians 1:17 "That the God of our Lord Jesus Christ, the Father of Glory, may give unto you the spirit of wisdom and revelation in the knowledge of him" This quest for further knowledge of God has been one of the most challenging man has faced throughout the passage of time. The creator has placed in man the need to discover the truths about God and his ways.

The thrust of theological studies has been to discover these truths. This unit will introduce the individual to basic issues of the nature, sources, and scope of theology. Theology must begin and end with God himself and the realization that God has revealed Himself through the Bible.



One needs to become familiar with the broad issues that will be discussed in this section so that he or she will be prepared to begin more in-depth theological studies. The challenge is for every Christian to "...know him, and the power of his resurrection, and the fellowship of his suffering..." (Philippians 3:10) This section has developed to assist in the discovery of Him.

## ***History & Polity of COGOP***

This course will focus on the roots and identity of the Church of God of Prophecy (COGOP) and its government and polity. This course is written from the perspective of a pastor with a concern for providing a general but significant orientation about the church to prospective members and interested parties. It might also find useful in broadening the education about the church (church of God of Prophecy).

In addition, this course may prove helpful in training prospective ministry personnel and providing information to those of other religious organizations who desire to obtain useful knowledge about the Church of God of Prophecy.

## ***Introduction to Counseling***

This course is designed to expose students to basic techniques in counseling. The course focuses on issues that people in general face, but special emphasis will be placed on situations within the Caribbean context.

It is assumed that students themselves have pursued/are pursuing their own healing to prevent counter transference. The scripture is the standard by which all theories and techniques are measured.

## ***Biblical Interpretation***

- Introduces students to essential terminology which is used in biblical interpretation.
- Examines the tasks of hermeneutics.
- Discusses approaches to Bible Study inductive & deductive study.
- Describes the 3 basic steps:
- Observation interpretation and application.
- Relates the significance of culture, history/geography, and language to the process of biblical interpretation.
- Analyzes the different genres of the Bible

## ***Evangelism***

This course is designed to equip and train lay-people to be mobilized to share their faith and be able to perform the task of Evangelism. It is centered on Ephesians 4: 11-16

## ***Homiletics***

This course is designed to emphasize the homiletical aspect of preaching. It focuses on sermon structuring and how to apply the structuring methods learned in the various kinds of literature found in scripture.

## ***Church Administration***

The course is designed for persons who are already in a place of church leadership or who are anticipating leadership responsibility. The course seeks to present an orderly comprehensive and theoretical illustrated framework of church administration. The course focuses on how the leader relates to organizations and its people, performance of administrative functions and leadership and ministry skills.

## ***Introduction to Communication***

NCBI is committed to provide a more practical approach in private and public speaking. The course is designed to highlight communication as a process, emphasizes the elements that must be taken into consideration when communicating, and underscore the value of effective communication in verbal spoken/ written and nonverbal communication.

## ***Youth Ministries***

The Youth Ministry Department needs visionary leaders to make a difference. As leaders, they must constantly be searching for new programmes, challenging and inspirational ideas to keep the Youth Ministries alive, relevant, and informative. The training of youth leaders and potential ministry leaders is paramount to the health of the organization. Youth ministry must develop the potential in our young people; meet their needs, personal interest, and spiritual welfare.

To reach, equip and develop youth leaders; so that Youth Ministry becomes:

- Purposeful, effective. and relevant to all youths
- Ministry orientated, specific and functional to those it serves.



## ***Effective Children's Ministry***

1. To demonstrate and develop an understanding of the Physical, mental, spiritual, and social development of children at the different stages and ages of their lives.
2. To demonstrate an understanding of theories of child development, and how they contribute to children and their relationship with God.
3. To demonstrate an understanding of the importance of developing and maintaining a good prayer life.
4. To demonstrate a willingness to use different teaching strategies at the appropriate time to improve children understanding of the principle of the Word of God.
5. To demonstrate an appreciation for the importance of praying preparing planning under the guidance of the Holy Spirit, to ensure effective ministry to children.
6. To demonstrate knowledge about the various policies on children's issues.
7. To show an appreciation for the role the importance of parents in imparting Godly values.
